BOARD OF SUPERVISORS			
Valerie Brown	C+	D+	Vote on Dutra is commendable; working for energy efficiency policy. Landfill position pro-divestiture is unsettling; did not support rail sites for Sutter. Has not reached out to environmental community. Dismissive towards public input.
Mike Kerns	D-	F	Biggest concern is whether all the resource extractors can sneak through before he terms out (Dutra, Roblar Quarry, gravel mining in Alexander Valley, etc).
Shirlee Zane	A-	B	The lone environmental vote on the Board at this time. Leadership on Dutra, County Landfill was outstanding. Backing of Rabbitt was suspect. Diplomacy skills are slow to be showcased at times. Is available for public input, dialogue.
Paul Kelley	F	D+	Actions speak louder than words; still voting for the resource extractors. His failed bid to become water agency chief is a blessing to the public.
Efren Carrillo	C-	C+	His support for the gravel and extraction industries, demonstrated with his flip-flopped support of Dutra, means we should not trust him to honor the environmental legacies and visions of west county. Available to the public.

Maryanne Brigham	D+	C-	Wanted a much larger UGB. Quit her term early, no longer on Council.
Carol Russell	B	A	Only no vote on defunct Thyme Square project. Support of UGB w/ Asti included a negative. Committed public leader who is invested in the community.
Jessalee Raymond	C-	C-	Supports development over most other considerations. Did not listen to citizens about removing Asti from the UGB. Is active in community.
Joe Palla	C-	C	Asti support for UGB is disappointing. Environmental concerns aren't a priority.
Gus Wolter	C-	B-	Most open councilmember to improving language in the UGB, but ultimately would not budge from inclusion of Asti. Reaches out to the public, available.
